

# COMMUNITY STANDARDS

## WE LOVE FREEDOM! BUT IT ALSO HAS ITS BOUNDARIES.

This is just a short SUMMARY!

For the full information, please read through the complete Community Standards!

We want every user to be able to flourish freely with us. But these freedoms come with boundaries - these lie where other people could be injured or endangered due to a website's content. We are aware of this responsibility, so we use our Community Standards to define the [website content](#) that we **don't allow**:

### PHYSICAL AND MENTAL HEALTH RISKS



Anything that could **violate** or endanger someone's **dignity or health**, e.g.

- *self-harm*
- *violence, abuse*
- *harassment, bullying, discrimination*

### DRUGS AND NARCOTICS

INCL. LEGAL HIGHS, SUCH AS BATH SALTS, HERBS, ETC.



Anything that could directly or indirectly promote the use of **psychoactive substances**, e.g.

- *trade or mediation*
- *information, schemes, or formulas*
- *supporting, advising, or downplaying consumption*

### WEAPONS AND DANGEROUS OBJECTS



Anything that could directly or indirectly **encourage** the use of objects that are especially likely to **harm people**, e.g.

- *firearms, batons, or side arms*
- *accessories or parts*
- *explosives, aerosols*

## ENDANGERED ANIMAL AND PLANT SPECIES



Anything involving the trade or procurement of **endangered or threatened species** and products derived from them, e.g.

- *ivory or tusks*
- *promoting poaching*
- *products derived from endangered species*

## TOLERATED BY SOCIETY, BUT NOT BY US



We also prohibit the supply of the following **goods and services**:

- *Alcohol, CBD*
- *Tobacco, tobacco-like products (e.g. vape juices), and associated devices for consumption (e.g. e-cigarettes)*
- *Sexual services*

## CRYPTO-CURRENCY



Since cryptocurrency is often used in connection with illegal business, we prohibit:

- *Its trade*
- *Accepting payments in cryptocurrency*
- *Contracts for the mining of virtual currencies*

Anything that hinders open and fair competition or its distortion. We also reject fraudulent activities in order to protect businesses and consumers from them. Therefore, we prohibit e.g.:

- *Content that misleads other people or companies about products in order to take advantage of them*
- *Pyramid schemes and snowball systems, multi-level marketing*
- *Gambling, lottery and roulette systems, sports betting*
- *Content that's used to distribute unsolicited advertising or spam*
- *Content that contains viruses, Trojans, keyloggers, or other malware*
- *Content that's used to harvest or disclose personal information*
- *Artificially increasing social media presence*

## HATE SPEECH AND FAKE NEWS



Anything that hurts someone's **personal honor or defames, insults, excludes, agitates** individual groups or minorities, or promotes or calls for violence against them. ("**Hate Speech**")

We also do **not tolerate lies**, such as information or claims that are proven to be false ("**Fake News**") and that **mislead** others or **endanger** the common good. In particular, this includes:

- *Misinformation about medical aspects (e.g. deliberately misrepresenting information about the effects of vaccines)*
- *Reichsbürger movement (e.g. the Federal Republic of Germany doesn't exist at all and its institutions should be combated)*
- *Conspiracy theories, if they're proven to be false and are potentially dangerous.*

## DANGERS TO CHILDREN AND YOUNG PEOPLE



Anything that could jeopardize the special protection of **children or young people**, regardless of whether they are part of the content or they could get hold of the content. In particular, this includes:

- *Publishing or selling child and/or teenage pornographic content*
- *Instructions promoting sexual abuse*
- *The distribution of sex dolls that have a child-like appearance*
- *Media of minors who are not fully-clothed, or general model photos and videos*
- *Content that violates the UN Convention on the Rights of the Child*
- *Drawings, animations, or similar representations that meet the previous criteria*

## NATIONAL SOCIALISM AND MASS INSTIGATION



We do not accept any **National Socialist or discriminatory speech** and we condemn the glorification or trivialization of the **Nazi regime**. We, therefore, prohibit any items or content related to it, such as:

- *medals, badges, or other decorations related to the Nazi dictatorship*
- *images of Adolf Hitler, other Nazi officials, or anti-constitutional symbols (e.g. swastika)*
- *books and other media with discriminatory, degrading, or Nazi ideological content*
- *clothing brands that are a distinctive feature of far-right extremists*
- *the denial, glorification, or trivialization of the genocide of Jews and other groups, or what happened in the concentration camps*

We prohibit anything that aids the **creation or circulation** of counterfeit documents. In particular, this includes:

- *Vaccination certificates/other health certificates*
- *Passports, driving licenses*
- *Certificates*

## COUNTERFEIT DOCUMENTS



Anything that infringes on someone else's **intellectual property**, e.g. their

- *copyright, trademark, patent right, design right*
- *right to their own name or likeness*

## INTELLECTUAL PROPERTY INFRINGEMENT



If we receive a **report of a violation** of our **Community Standards** or discover it ourselves, we usually proceed as follows (depending on the type and severity of the violation):

Jimdo will contact the website operator, inform them of the violation, and ask them to remove the content immediately.

If the content is not removed, we will take further action, e.g. blocking/disabling the website or taking legal action.

The website operator can comment on this complaint by email, for example.
